HEARING OF DELEGATIONS

Comfort Dog Ministry—Diane Goldenstein and Dean Henrichs introduced Mahlah to the school board. Mahlah is a part of Our Savior Lutheran Church's "Comfort Dog Ministry." Comfort Dog Ministry is a national ministry with a goal of reaching and getting out to the community to provide comfort from suffering. To become a comfort dog, Mahlah has received over 2000 hours of training. Mrs. Goldenstein and Mr. Henrichs wanted the board to know that Comfort Dog Ministry is available to the students, school, and community for fun and in a time of need. When Mahlah visits the school in a time of tragedy, students are encouraged to pet her, which in turn has a calming effect, allowing for students to open up about their grief.

The following concerns were voiced by Brian Neukomm: Concern for the upcoming FMLA leave of first grade teacher, Kelsie Pool in November 2017. Does the school administration have names of substitutes to fill the position? He does not want to see numerous teachers fill the position. He wanted to know the board's progress on his cafeteria concerns from the March meeting. He informed the board that he has turned his Statement of Economic Interest into the county for the open school board position. Lastly, Mr. Neukomm wanted to know what the details were for the Kindergarten teacher's upcoming resignation at the end of the 2016-2017 school year. The board encouraged him to ask the teacher why her decision was made.

Jeannie Seggebruch asked the board if anything has been done in regards to the business teacher position being filled. The position has been posted on Appli-Track numerous times. There is a shortage of business teachers across the state. Mrs. Marshall, guidance counselor for the district, said that accounting classes have been offered online, with mixed reviews.
